

SLAM DUNK SWEEPS

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM THE PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Slam Dunk Sweeps ("Sweepstakes") is sponsored by Pilot Travel Centers LLC, 5508 Lonas Drive, Knoxville, TN 37909 ("Sponsor") and is administered by Prize Logic, LLC, 25200 Telegraph Rd., Suite 405, Southfield, MI 48033 ("Administrator").

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on February 1, 2018 at 12:00 PM Eastern Time ("ET") and ends on February 28, 2018 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the forty-eight (48) contiguous United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void in Alaska, Hawaii, and where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

- 3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant must visit www.slamdunksweeps.com ("Website") and enter his/her valid e-mail address. The entrant then must register by entering the information requested on the registration form, which may include, without limitation: his/her complete first and last name (initials are not permitted), telephone number, and affirmation that he/she is at least eighteen (18) years of age and has read and agrees to be bound by these Official Rules. Upon completion and submission of the registration form, an eligible entrant will receive one (1) entry into the Sweepstakes. After completing registration, each day during the Sweepstakes Period, the entrant may visit the Website and submit his/her valid e-mail address used when registering for this Sweepstakes to receive one (1) additional entry into the Sweepstakes.

IMPORTANT: If using a mobile device to participate in the Sweepstakes, data rates may apply. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless providers' pricing plans.

Limit: Limit one (1) entry per entrant per day during the Sweepstakes Period. For purposes of the Sweepstakes, a "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day, except for February 1, 2018, when a day will begin at 12:00 PM ET and end at 11:59:59 PM ET. If an entrant attempts to enter more than once per day, all entries after the first entry will be invalid.

- 4. RANDOM DRAWING:** On or about March 1, 2018, the Administrator will randomly select one (1) potential winner from all eligible entries received during the Sweepstakes Period. The winner is

considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZE, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Prize (1): The prize is a seven (7)-day/six (6)-night trip for the winner and up to three (3) guests to attend the 2018 Southeastern Conference Men’s Basketball Tournament in St. Louis, Missouri from (“Prize”). The Prize includes:

- (i) round-trip coach class air transportation to St. Louis, Missouri from a major commercial airport near the winner’s residence from March 6 to March 12, 2018;
- (ii) seven (7) days and six (6) nights hotel accommodations (two (2) rooms, double occupancy) at a hotel to be determined by Sponsor in its sole discretion;
- (iii) up to four (4) suite tickets for all games in the 2018 Southeastern Conference Men’s Basketball Tournament, occurring March 7 to March 11, 2018;
- (iv) select ground transportation (determined by Sponsor, in its sole discretion);
- (v) a meet and greet with Paul Finebaum and access to select SEC FanFare activities, subject to Sponsor’s discretion; and
- (vi) a \$1,000 check made payable to the winner.

If winner resides within 100 miles of St. Louis, Missouri, ground transportation may be substituted in lieu of air transportation in Sponsor’s sole discretion and no additional compensation will be provided.

The winner and his/her guests must attend all games included as part of the Prize as a condition of accepting the Prize.

The winner and guest(s) will depart on Tuesday, March 6, 2018 for St. Louis, Missouri and return on Monday, March 12, 2018. Winner and guest(s) must travel on the same itinerary. The winner and guest(s) are solely responsible for obtaining any desired or necessary travel documents (including without limitation a valid government-issued photographic identification).

All travel dates and arrangements are subject to change based on availability and provider’s approval. No changes will be made to travel details once any element(s) of the travel arrangements have been booked, except at Sponsor’s sole discretion.

The winner’s guest(s) must each be at least eighteen (18) years of age or be the minor child or legal ward of either the winner or another guest accompanying the winner on the trip. Each guest (or if a minor, his/her parent or legal guardian on the minor’s behalf) will be required to complete and return a Liability & Publicity Release prior to hotel booking.

The Winner and guest(s) are responsible for all travel expenses not included herein, including airline baggage fees, gratuities, meals, ground transportation, and any other incidental costs or expenses related to participation in the Prize. Winner and his/her guest(s) hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of the Prize.

The Winner and guest(s) will be required to provide a major credit card upon check-in and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of the winner. All hotel accommodations and booking arrangements will be administered by Sponsor’s authorized designee.

If any game or event included in the Prize is delayed, postponed, or canceled for any reason whatsoever, the winner will not be reimbursed for that portion of the Prize. Tickets are awarded pursuant to a revocable, nontransferable license that is personal to the winner and may not be sold, resold, auctioned, bartered, assigned, exchanged, placed in commerce, transferred, given away, donated, or otherwise conveyed. A violation of these restrictions shall revoke winner's license, and may result in the Prize not being honored. Sponsor reserves the right to remove or to deny entry to any winner and/or guest if such winner and/or guest violates the previous restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person at the any game or event.

The Prize ARV is \$20,000. The actual Prize value may vary depending on point of departure and fluctuations in the cost of air transportation and the number of guest(s) who participate in the Prize. Any difference between the estimated ARV and the actual value of the Prize (if less than the ARV) will not be awarded.

B. Odds of Winning: The odds of winning the Prize depend on the total number of eligible entries received during the Sweepstakes Period.

C. General: One (1) Prize will be available in the Sweepstakes. In no event will more than one (1) Prize be awarded. If, for any reason, more Prize notifications are sent (or more claims are received), Sponsor reserves the right to award the Prize through a random drawing from among all eligible Prize claims received. No Prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute the Prize or a portion of the Prize of equal or greater value in case of unavailability of the Prize or force majeure. The winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. The Sweepstakes Entities shall not be held responsible for any delays in awarding the Prize for any reason. If after a good-faith attempt Sponsor is unable to award or deliver the Prize, the Prize may not be re-awarded.

6. HOW TO CLAIM THE PRIZE: The potential winner is subject to verification of eligibility and compliance with these Official Rules. The potential winner will be required to sign and return an Affidavit of Eligibility/Liability/Publicity Release (including, without limitation, his/her Social Security Number as required by law) (except where prohibited) and any other requested documents (the "Documents") within twenty-four (24) hours from the time of attempted notification or the Prize may be forfeited in its entirety and/or awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Sponsor reserves the right to disqualify the potential winner/guest based on the results of such background check if Sponsor determines in its sole discretion that awarding the Prize to any such individual might reflect negatively on the Sponsor. Upon verification, the potential winner will be contacted for travel arrangements. If the potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept the Prize, or winner notification is returned as undeliverable or the potential winner fails to respond to a winner notification within the timeframe specified in such winner notification, the Prize may be forfeited. If the Prize is forfeited for any reason, it may be awarded to an alternate potential winner, at the Sponsor's sole and absolute discretion, selected at random from the remaining pool of eligible entries received, time permitting. Prize is not transferable and includes only the items specifically listed as part of the Prize. If the Prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right to substitute the Prize or portion thereof with another Prize of equal or greater value. Any portion

of the Prize not accepted by winner will be forfeited. Federal, state, and local taxes on the Prize and any expenses relating to the acceptance of and use of the Prize not specified herein are the responsibility of the winner. Sponsor will issue an IRS Form 1099-MISC for the winner. The Prize will only be awarded to a verified winner. Failure to provide social security number may result in withdrawal of the Prize.

- 7. LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents (“Released Parties”) are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; or (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. DISPUTES:** THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF MICHIGAN, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE OAKLAND COUNTY, MICHIGAN. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“AAA RULES”). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS’ FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
